# Asansör İstanbul 2023 became the world's leading fair in the industry!

International Asansör İstanbul took place this vear with the participation of a total of 363 companies from Turkey and abroad. It exceeded the number of visitors of 2022 to become the largest event in its region. The four-day fair was attended by 24,314 professionals of which 6.906 foreign visitors from different continents, including Algeria, Egypt, Iran, Iraq, Kazakhstan, Kosovo, Lebanon, Libya, Russia, Saudi Arabia. Getting stronger every year, the International Asansör İstanbul will have its next edition in March 2025.

Held by Tarsus Fuarcılık with the support of AYSAD (Association of Elevator and Escalator Industrialists), the 18th Asansör İstanbul International exceeded expectations. The event took place in 8 halls at Tüyap Beylikdüzü Exhibition Center, where faster and safer elevator technologies were exhibited. The fair became the largest event in its region in terms of square meters, number of exhibitors, and visitors coming from Turkey and abroad. This year, the motto was "New world. new opportunities". Asansör İstanbul 2023 has more

than realized all the achievements promised by this message. Zekeriya Aytemur, General Manager of Tarsus Fuarcilik, indicated, "Every edition adds new visitors, most of whom are buyers, from different countries, to the portfolio of Asansör İstanbul, and it definitely takes its place on the fair agendas ofindustry professionals."

## The elevator world met in Istanbul!

The Asansör İstanbul 2023 was attended by elevator assembly, contracting maintenance and companies, elevator component manufacturers and suppliers, construction contracting and companies, real estate managers, building owners, elevator users, project, architecture, engineering and consultancy companies, procurement foreign teams. certification bodies, NGOs, public institutions and academics. The fair exhibited innovations in all transportation vertical technologies, escalators and walkways, including residential commercial building and elevators. hospital elevators, domestic elevators and personal carriers, automobile elevators, freight and service elevators and elevators for disabled persons.





### Elevator standards suitable for earthquake zones were discussed

This year's main agenda item of the conference program was "SEISMIC REGIONAL ELEVATORS". As part of this agenda item, a panel, "Elevators and Buildings Subject to Seismic Conditions" was moderated by Sefa Targit, Vice President of the Turkish Machinery Federation (MAKFED) with speeches from Esfandiar Gharibaan, Chairman of CEN European Standards Committee TC 10, Paolo Tattoli, CEN Committee Seismic expert and Chairman of the Italian UNI/CT 019 Chairman, Prof. Dr. Erdem IMRAK, Faculty Mechanical Member of Engineering at ITU, and Dr. Ferhat Çelik, member of the European Lift Association's (ELA) Components Committee. They shared information on Elevators usage in earthquake elevator-building zones. the interconnection, operation and commissioning of elevators during an earthquake.

# Professional Technical Regulations

The Safety Technical Committee of the MFSZ (Magyar Felvon—SzšvetsŽg) - Hungarian Lift Association - with the support of the relevant government authorities (listed below), developed and enforced the SZME regulation - Professional Technical Regulations, whose objective is to provide specifications regarding the domestic elevator industry.

Organizations contributing to the preparation of technical specifications:

- Budapest Capital Government Office,
- Industrial Regulation
  Department of the Ministry of
  Economic Development,
- Hungarian Lift Association,
- Hungarian Chamber of Engineers, Department of Material Handling Machinery, Construction Machinery and Elevators,
- Lift-S Association.

Since the EN 81-80 SNEL Standard has not been introduced yet in Hungary, 20,000 elevators are still awaiting renovation.

The regulation does not replace the standard, but its application is expected.

#### Interlift Fair 2023

### Run on the world's leading trade fair for lift technology: Around 500 exhibitors expected at the interlift 2023

Augsburg — Very pleasing prospects for the interlift 2023: with more than 350 registrations in the meantime, the leading trade fair for the lift industry is already surpassing the previous event several months before the start. The organiser AFAG is currently expecting around 500 participating companies - all the available halls at the Augsburg Trade Fair Centre will then be occupied.

This means that Interlift is approaching the level of 2019 again, and in terms of international attendance it could even set new standards.

## Interlift: the industry's most international platform this year

The Interlift 2023 is set to be the most prominent trade fair of the lift industry this year: the current

share of 65% of foreign companies will grow with those involved from abroad coming from China, India, Italy and many more countries.

Italy leads the top 5 international participations with 16% of attendance, followed by Turkey with 14%, Spain (10%) and Switzerland and Austria with 3% each. This order will change shortly, however, when the registrations from China will arrive, including a large joint participation with about 40 companies alone. Also, 9% of the exhibitors are set to come to Augsburg for the first time.



# International knowledge platform accompanying the trade fair: VFA Forum interlift

# Committees & WGs

### **SAEL WG**

Upgrading existing lifts: how to make the biggest improvements in safety, accessibility and energy efficiency

Recently the Safety, Accessibility and Energy Efficiency in Existing Lifts (SAEL) Working Group finalized a dedicated white paper outlining a list of possible ways of modernizing existing lifts.

The white paper contains a comprehensive technical catalogue of modernization interventions available on the market to upgrade the stock of existing lifts contributing to enhance their safety, ensure better accessibility for all users, and improve the energy efficiency of buildings.

The ELA SAEL white paper provides useful guidance for building owners and all stakeholders in the lift industry to improve the "mobility chain" in existing buildings, through the modernization of vertical passenger transportation, which is present almost everywhere in the built environment.

In a nutshell, upgrading existing lifts is a sustainable option, and can generate significant social,

environmental and economic benefits for individuals, society at large, and our planet. In this way, building owners can identify a clear path to undertaking these works to ensure they choose the solution that will offer the most benefits.


ELA recommends consulting the entire white paper to get a detailed overview of all the modernization interventions to upgrade existing lifts. It should also be circulated to all the stakeholders – policymakers, authorities, building owners, national lift associations - involved in enabling the accessibility and mobility of people in buildings, districts and cities.

### **ESMO WG**

#### **SNEE Brochure**

The SNEE Brochure (Safety Improvements of Escalators and Moving Walks in Operation under EN 115-2:2021) was released by the ELA ESMO WG, in order to raise awareness about the updated European standard EN 115-2:2010, which includes the new



measures in existing Escalators and Moving Walks. This brochure describes the key risks and corrective measures for achieving acceptable safety levels per EN 115-2:2021.

### **Brexit Information Note**

The Brexit, which took place on 31 January 2020, has an impact in the lifts, escalators and moving walkways, areas covered by ELA. The ELA Components Committee drafted and released a Brexit Information Note (available to ELA members), with the objective to provide an update on the consequences of Brexit for the trade for systems and in particular their safety components.



### **SRI WG**

## SRI assessments on Lifts and Escalators

The ELA SRI WG is working on the compilation of functionalities of SRI assessments on Lifts and Escalators. Each functionality presents the outcomes of the SRI assessment, an overview of the aspects positively impacting the evaluation, as well as potential suggestions for improvements. A first proposal has been reviewed with EUBAC members. having Lifts and Escalators as an additional SRI service is essential from their perspective. ELA SRI WG is now exploring the proposal and will work on a White paper that can be widely used in this regard.

A first contact with the experimenting countries has been established already, and the collaboration will intensify at a later stage of the study to better understand and evaluate the SRI need for Lifts & Escalators.

ELA is actively participating to the SRI platform WG2 and contributes to the writing of the procedure for revising the SRI with additional domains or services in future. This platform is an exchange forum involving building professionals interested in the SRI, and more generally in smart and efficient buildings.



In March 2023, the 3rd Plenary Meeting of the SRI Platform was held. This meeting was an opportunity to hear about the latest updates from the front running Member States which are currently implementing an official test phase of the SRI.

The SRI platform working groups will also present their latest work on maintenance & potential extension of the SRI calculation methodology, and around the SRI value proposition and supporting measures.

### **BIM Information Note**



Digitalization & The ELA Cybersecurity Committee released the **Building Information Model** (BIM) Information Note, available to ELA members in the dedicated members' area. The purpose of this information note is to provide an overview and tools about BIM for the lift industry, useful for the management of projects. The BIM is a set of digital representation tools in the construction sector, which use is increasing in all of Europe.
